ⁱⁱ The FY19 Final House Budget changes the language in this line item to say that programs shall be administered by "direct service providers" instead of by "shelters" (which is the term used in the FY19 House Ways & Means Budget).

ⁱⁱⁱ The Department of Mental Health has indicated that the increase to Line Item 5046-0000 in the FY19 Governor's Budget Recommendation includes an increase of \$1 million to support DMH rental assistance.

^{iv} The FY19 Final Senate Budget includes language in this line item stating: "provided further, that not less than \$45,000 shall be expended for the community impact unit of the police department of the town of Barnstable in consultation with NAMI Cape Cod, Inc. and the county of Barnstable for a designated emergency site that shall provide shelter, address basic human needs and provide protective oversight and assistance for the high-risk chronically homeless population on Cape Cod; provided further, that not less than \$20,000 shall be expended for the county of Barnstable to conduct a study of the Plymouth county outreach project and to determine the viability of replicating the project in the county of Barnstable."

^v In the FY18 Final Budget, the line item contains language specifying that "provided further, that up to \$2,000,000 may be expended to provide assistance to households of all sizes and configurations including, but not limited to, elders, persons with disabilities and unaccompanied youth."

^{vi} The FY19 Governor's Budget Recommendation does not include the language from the FY18 Final Budget that specifies that RAFT may be used for households of all sizes and configurations.

^{vii} The FY19 Final House Budget does not include the language from the FY18 Final Budget that specifies that RAFT may be used for households of all sizes and configurations.

^{viii} The FY19 Final Senate Budget includes language specifying that not less than \$3,000,000 "shall be expended to provide assistance to households of all sizes and configurations including, but not limited to, elders, persons with disabilities and unaccompanied youths."

^{ix} The FY19 Governor's Budget Recommendation notes: "In addition to this funding, the administration expects to spend \$30,000,000 in fiscal year 2019 from the off-budget 'Substance Use Disorder Federal Reinvestment Trust Fund' established under Chapter 110 of the Acts of 2017."
