## **CoC Updates (YHDP and more)**

# **Springfield-Hampden CoC**

- 317 households served so far in FY25 61 are pregnant and parenting
- 181 YYA on the by-names list 31% male; 63% female
- 15 young adults living outdoors 12% white, 64% hispanic, 22% Black
- 19 young adults housed since September 75% female, 25% male; 11% white non-hispanic; 58% hispanic; 21% Black
- Fostering Youth Independence (FYI) vouchers 10 lease-ups since 9/1; 9 currently seeking apts.; 18 more confirmed eligible

### **Three County CoC**

- 70 YYA on the by-names list among those who answered the demographics question 11 Hispanic, 5 Black, 7 multi-racial
- housed 6 individuals since Sept.
- PSH program moved a YYA into new permanent housing; new move-ins as people transition out

### Discussion and Recommendations: The Network's FY26 budget and legislative priorities

Pamela sought the group's experiences and perspectives that will inform the Network Steering Committee's decision making for this coming year's budget debate and upcoming Legislative Session.

#### **FY26 Budget Recommendations**

We looked at our <u>FY25 budget priorities</u> as a starting point for discussion. Feedback included:

- Permanent supportive housing need more for this population many in the group echoed this need!
- Need more for parenting youth
- Greater eviction protections are critical
- Need to address younger youth (15-16 year olds) in need of housing and services

# 2025-2027 Legislative Session - begins in January, 2025

We looked at our last Legislative Session's priorities as a starting point for discussion.

The group felt most strongly about rent control and access to counsel, priority order of:

- rent control
- access to counsel
- TOPA (tenant opportunity to purchase act)
- Transfer fee for affordable housing
